3. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

Clear, Colorless Aerosol. Lemon Odor. Causes Eye and Skin Irritation. Contents Under Pressure.

EFFECTS OF ACUTE EXPOSURE

EYES:

Causes eye irritation. Symptoms may include redness and pain.

SKIN:

Causes skin irritation. Symptoms may include redness, rash and mild swelling.

INHALATION:

High concentrations of vapor or mist may cause nose, throat and respiratory tract irritation. Symptoms may include coughing. High concentrations of vapor or mist may also cause central nervous system effects including headache, dizziness and nausea.

EFFECTS OF CHRONIC EXPOSURE:

Prolonged or repeated contact can cause defatting and drying of the skin which may result in skin irritation and dermatitis (rash).

4. FIRST AID MEASURES

EYES:

Flush eyes with plenty of water while holding eyelids apart. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Do not put any medication in the victim's eyes unless instructed by a physician. Get medical attention.

SKIN:

This product is not aerosol flammable per flame extension test 16 CFR 1500.45. If this product is involved in a fire, evacuate area. Cool containers exposed to fire with water. MSHA/NIOSH approved self-contained breathing apparatus (SCBA) and full protective gear should be worn.

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

HANDLING:


