## 3. HAZARDS IDENTIFICATION

EYES:  
Causes eye irritation. Symptoms may include redness and pain.

**4. FIRST AID MEASURES**

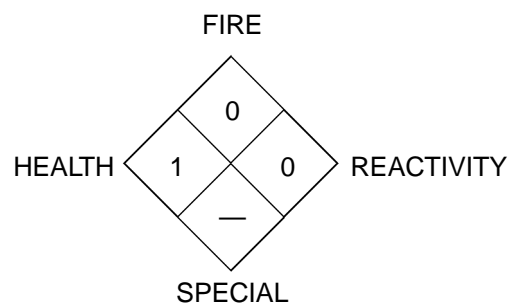
