**INGESTION:**

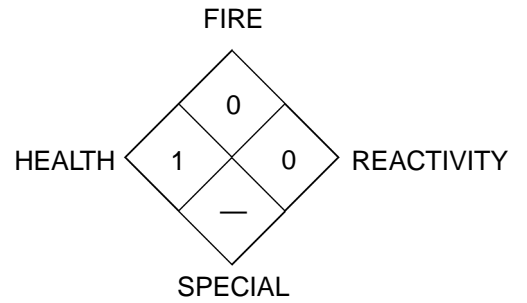
